Re: The Small Business and Family Enterprise Ombudsman

The NSW Business Chamber ("the Chamber") welcomes the opportunity to make a submission to the Small business and Family Enterprise Ombudsman Discussion Paper.

4. Build better infrastructure

We saw that to deliver on these policy initiatives the role of the Australian Small Business Commissioner would need to change – with additional powers and responsibilities to ensure the office could more actively contribute to reducing red tape, assist in the resolution of disputes and, perhaps most importantly, advocate for the needs of small business.

The Chamber is pleased to see that the discussion paper proposes to provide a number of new services and powers to the Commissioner including a dispute resolution service, an ability to participate in the regulation impact process and powers to investigate complaints about government and private sector practices that are adversely affecting small business.

The Chamber is however concerned with the proposed change in name of the Australian Small Business Commissioner to the Small Business and Family Enterprise Ombudsman. While the change to the title of ombudsman might better reflect the broader range of functions it is proposed to now provide the Commissioner, the Chamber believes that such a change would only serve to confuse businesses who are now actively engaged with state based Small Business Commissioners. Accordingly we would strongly encourage that the title be changed to the *Australian Small Business Commissioner and Ombudsman* to retain greater consistency.
