As discussed yesterday, industry are expressing some concern about the 1 July 2015 start date for key aspects of the Stronger Super regime. The purpose of this email is to set out what matters are starting on that 1 July date and to confirm an appropriate approach.

Choice product dashboard and portfolio holdings disclosure

These requirements are currently delayed until 1 July 2015 as a result of ASIC class order 14/443. The delay was to give government time to consider the responses from industry and others to the government's consultation paper on governance and transparency, which closed for comment on 12 February 2014. We are aware that there would need to be detailed regulations and, in the case of the dashboard, an APRA form developed to support the disclosure regime. As mentioned to Treasury in meetings last year, our preference would be for these class orders to be extended (if this is what needs to occur) as soon as possible, in order that the industry has certainty about the regime that will apply on 1 July 2015. If there is no announcement from the Minister by the start of March this year, and no draft regulations, our intention would be to issue class orders extending the timeframe for these requirements until 1 July 2016 before Easter this year. Similarly, we would look to extend CO 13/1534 (which allows the use of hyperlinks to product dashboards in periodic statements) until 1 July 2016, so as to align with the new dates for Choice dashboards.
