

2. The net total number of cigarettes (sticks) that have been cleared, refunded and exported.

The data below have been provided to Treasury by the Australian Taxation Office (ATO) and the Australian Customs and Border Protection Service (Customs). They show net clearances of cigarettes (that is, after subtracting refunds which includes exports¹) by month of payment for the ATO, and month of processing for Customs. The ATO totals, but not those from Customs, are also net of tobacco products destroyed with the introduction of plain packaging. Between December 2012 and May 2013, Customs' Tobacco Refund Scheme refunded the duty previously paid on 191,848,090 sticks. These refunds cannot be related to monthly net clearances on a comparable basis to other Customs data presented in this document.

Between December 2012 and May 2013, Customs' Tobacco Refund Scheme refunded the duty previously paid on 73,742.32 kilograms of tobacco products.
