## Re: [Redacted] - Reply to GST free on women's health products

Thank you for your email regarding interested parties to make submissions on this policy and tax proposal change.

It is inadequate because every health care product must have a registration system number with Treasury and when send out any changes to law there must be a system number that can be checked and verified by all. This means there may be 4 or 5 brands selling the same product thus this means you have a lot of work to do to catalogue each brand and record each brand within Treasury so that in fact you know the impact of the policy.

Every business that sells health products must do a specific return about those health products to the Tax Office. Again this is because more detailed reports and information are needed if changes to policy are to go from GST paid to GST free. It also helps with modelling. The Tax Office must now supervise health products as individual items and precisely what health products are being sold where and why. This can only be done by gathering data. Presently the Tax Office is not gathering data on tens of thousands of products. Secondly, Joe Hockey.
