- minor amendments to the *Trade Practices Act 1974* (TPA) reflecting new regulatory powers for the ACCC in relation to the National Broadband Network (NBN); and
- limits on the application of the *Corporations Act 2001* for the sale of the Government's stake in NBN Co.

- We do not have any concerns with the proposed amendments.
  - Amendments to sections 25 and 155 of the TPA will provide consistent application of the ability of the ACCC to delegate its powers and the ACCC's information gathering powers.
  - Proposed limits on the Corporations Act are consistent with legislation governing the sale of Telstra and Medibank Private.
    - : If agreed, the Minister for Financial Services, Superannuation and Corporate Law will notify the Ministerial Council for Corporations of the proposed clauses affecting the corporations legislation and circulate of a copy of the Bills to the Council in accordance with the *Corporations Agreement 2002*.
