#### 1 Name

# 45.30 Governance standard 6—Maintaining and enhancing public trust and confidence in the Australian not-for-profit sector

Object

(1) The object of this governance standard is to maintain and enhance public trust and confidence in the Australian not-for-profit sector by ensuring that a registered entity's governance enables it to be accountable for its past conduct relating to institutional child sexual abuse.

Standard

- (2) A registered entity must take reasonable steps to become a participating non-government institution if the entity is, or is likely to be, identified as being involved in the abuse of a person:
  - (a) in an application for redress made under section 19 of the *National Redress Scheme for Institutional Child Sexual Abuse Act 2018*; or
  - (b) in information given in response to a request under section 24 or 25 of that Act.
  - Note 1: The reasonable steps that a registered entity could take include agreeing to participate in the National Redress Scheme for Institutional Child Sexual Abuse (the *Redress Scheme*) and becoming a participating non-government institution.
  - Note 2: Once a registered entity has become a participating non-government institution, the entity is subject to the Redress Scheme.
- (3) For the purposes of subsection (2), it does not matter whether the application is valid.

# Part 3-1—Application, saving and transitional provisions

Division 1—Application of the Australian Charities and Not-forprofits Commission Amendment (2021 Measures No. 1) Regulations 2021

## 70.1 Application

- (1) The amendments made by the amending instrument apply in relation to applications for redress made under the *National Redress Scheme for Institutional Child Sexual Abuse Act 2018* before, on or after the day the amending instrument commences.
- (2) In this section:
