If you wish to discuss it please do not hesitate to call.

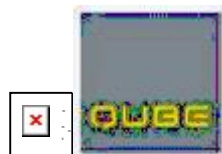

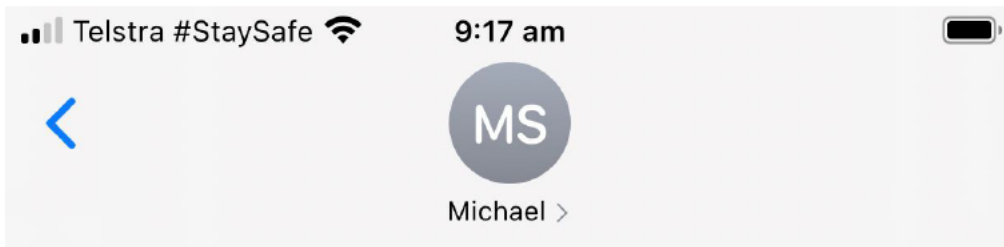
