#### Subject: Pre-Budget Submission - Lake Macquarie City Council

Thank you for the opportunity to submit a pre-budget submission for the 2021-2022 Federal Budget. Attached is a copy of Council's 2020-2022 Advocacy Priorities showcasing our City's attributes, what we're advocating for, and how we're going about it.

Home to more than 205,000 people covering the Federal electorates of Hunter, Shortland and Newcastle, Lake Macquarie is one of NSW largest regional City's experiencing rapid and complex changes. Located 90 minutes from Sydney and the largest City in the Hunter<sup>1</sup>, we are seeing:

- a 28 per cent decline in manufacturing and 20 per cent decline in mining<sup>2</sup>
- an increase in workers relocating from metropolitan cities
- significant private-sector investment in construction and development, which is increasing the strain on existing infrastructure and services
- a lack of spending on catalytic infrastructure in our broader region as part of the nation's post-COVID recovery plans, and
- compared with Lidell and Bayswater in the Upper Hunter, minimal engagement over the future closures of the Vales Point and Eraring power stations on Lake Macquarie (Vales Point will close in just seven years, six years before Bayswater).

Lake Macquarie City Council is a capable partner and collaborator with objectives for regional prosperity beyond our own boundaries. Below are just some of the opportunities and projects that the 2021-2022 Budget could support.

Project name	Summary	Cost and outcome
North West Catalyst Area transport improvements	The location of Costco Wholesale's first warehouse in regional Australia, Lake Macquarie's North West Catalyst Area needs funding to improve major roads and intersections to improve access to this key site.	A four year \$10m rolling program would upgrade already failing roads and intersections associated with the Catalyst Area
Hunter Region Sports Centre Expansion and National Trampoline Centre of Excellence	A shovel-ready DA approved project that will elevate the facility to be used as an international facility for athletics as well as Australia's first and only Trampoline Centre of Excellence.	Council is contributing \$7.3m to the project and is seeking a further \$27.4m to see the catalytic investment proceed

Lower Hunter Freight Rail Bypass	A Freight Rail Bypass separating rail freight (including coal) from passenger rail between Fassifern and Newcastle	Transport for NSW is leading this project and exhibition of the proposed bypass corridor is expected in early 2021
National Agency for Resources and Energy Transition	A Federal agency, with appropriate decision-making authority, charged with tackling the transition of jobs affected by the decline in mining and manufacturing communities across regional and rural Australia.	Council staff suggest the establishment of the National Faster Rail Agency could be used as a model for the transition agency

#### LOCATION

- 90 minutes to Sydney CBD

## **KEY ADVOCACY INITIATIVES FOR 2020-2022**

## We're advocating for:

- Red tape reduction at all levels of Government
- Pilot projects to explore sequential land use activities, such as the adaptive reuse of ex-mining land
- Increased investment in transport infrastructure (road, rail, and active transport) and interchange facilities to encourage public transport service utilisation
- Regional connectivity improvements to provide residents, visitors and businesses with unhindered access to the internet (5G, public Wi-Fi, fibre networks, etc).
- Expansion of tertiary education opportunities within Lake Macquarie

City and the surrounding Hunter and Central Coast regions

- Faster road and rail connectivity between Sydney, Gosford, Lake Macquarie and Newcastle to support growth and decentralisation of government and non-government services
- Tangible support for industry initiatives to develop clean energy and power generation
- New mechanisms and funding to support the transition of workforces affected by decline in traditional sectors of mining, manufacturing and energy production

# How we'll do it

- Identify feasible initiatives and create opportunities for pilots, prototyping and proof of concept
- Collaborate with both the public and private sector to deliver outcomes
- Be adaptive in our approach to advocacy, using real-world evidence and analysis to make our case for change
- Value add before we value ask, recognising that we can no longer rely on governments to invest in Lake Macquarie City without us doing so first
- Harness the expertise of Dantia (the Lake Macquarie Economic Development Company), to inform initiatives that will attract and accelerate investment and job creating opportunities by existing and new businesses

- Respond strategically to the impacts of the COVID-19 pandemic and transform practices and processes so that the City can:
- + re-establish and accelerate social and economic activity
- + create confidence and certainty to secure investment and jobs from public and private sectors
- + diversify the business base and become more agile and resilient to negative events in the future
