Our fundamental concerns remain in this redraft. If the policy seeks to increase decarbonisation, then technologies which mitigate emissions from fossil fuels should be included, and the policy should explicitly identify this.

Overarching comments below:

- If the aims and objectives in the policy is to support the decarbonisation of the regions energy systems, focus should be made on supporting abatement technologies in coal fired power stations. This is not mentioned in Principle 2 *Building a Sustainable and Resilient Energy Future*.
- In addition, neglecting the role of existing firmed capacity is likely to result in insecure
 energy networks as intermittent renewables increase network share. Supporting policies
 which promote the decline of existing firmed capacity will likely result in greater energy
 insecurity.
- We recommend Para 74 identify the importance of technological upgrades to coal fired power stations which reduce emissions. This has not been mentioned and results in an unfortunate information gap. Should the ADB not support this activity then it should be explicitly mentioned in this section.
 - Suggest the following change (in red): Para 74- ADB will not support coal mining, processing, storage, and transportation, nor any new coal-fired generation (aside from technological upgrades that mitigate emissions from existing power stations).
