It would seem to me that a "franked" dividend can only be paid if the company has sufficient franking credits. The franking credits can only be obtained by the payment of company tax.

Surely a company that has paid its share of tax is entitled to use the franking credits as it sees fit, including by borrowing to fund the dividend payment.
