I would like to advise you of the arrangements for the Budget lock-up at Parliament House on Tuesday 14 May 2024.

Invitations to the Budget lock-up will be extended to you and two (2) ongoing employees of your office. External advisers are not permitted to attend.

Lock-up logistics

Your office has been allocated **Committee Room 1R4** from 1.30 pm until 7.30 pm.

Electronic and printed copies of the Budget papers will be available in the lock-up. Budget documents cannot be taken out of the lock-up room until 7.30 pm.

Mobile phones, including smart watches cannot be taken into the lock-up. Secure storage facilities will be available outside the lock-up area.

Other devices (for example laptops and tablets) can be taken into the lock-up but must be switched to flight mode.

There will be limited opportunity to submit questions to Treasury officials during the lock-up and it cannot be guaranteed that questions will be answered on the day.

Please note: no catering will be provided – attendees will need to bring their own food and drink.

Conditions for entering and leaving lock-up

Attendees are required to agree to confidentiality terms and conditions confirming they will not disclose the information received in the lock-up prior to 7.30 pm.

Attendees may enter the lock-up any time from 1.30 pm.

Senators and Members of Parliament may leave the lock-up from 7.00 pm, but they **will not** be permitted to take the Budget documents. Alternative arrangements can be made for these copies to be delivered to the relevant offices after the embargo is lifted.

Dear Dr Chalmers,

APRA prudential standards for new ADI entrants – uneven playing field

A constituent, who operates a financial services company in Curtin, has raised concerns in relation to the APRA's authorisation process for new authorised deposit-taking institutions' (ADI), through the direct licensing pathway.

Following interactions with APRA over several years, this constituent is concerned that the current authorisation process creates regulatory inequity for new entrants compared to established banks. Noting the need for tight regulation to protect depositors' interests and the operational risks of new entrants, this constituent considers this inequity will set up new entrants to fail, impacting competition in this industry to the detriment of consumers and to the benefit of established banks.

This constituent believes APRA is acting beyond its legislative obligations under the *Banking Act 1959 (Cth)* and APRA Prudential Standards. His concern is in relation to APRA's Guidelines "Licensing: Locally-Incorporated ADIs" (August 2021), which were introduced after his application was submitted. This constituent is concerned APRA is introducing commercial judgements into its interpretation and advice, instead of all entrants being subject to the same regulatory setting.

Noting the concerns detailed, can Treasury confirm these guidelines were independently reviewed prior to their implementation to ensure the guidelines set out appropriate requirements for new entrants?

Thank you for your time today and for considering my proposed amendments (attached).

1. *Requiring a sector assessment*

As far as I can see, there is no definitive requirement for a sector assessment before Future Made in Australia support can be provided. If there is an explicit requirement, please let me know where.

If this is not explicit, one option to ensure that no support is given prior to a sector assessment being undertaken would be to include the following (and attached) amendment:

11A Requirements before providing Future Made in Australia support

Future Made in Australia support must not be provided to a person in relation to a sector unless:

- (a) a sector assessment for the sector is conducted in accordance with section 8; and
- (b) the sector assessment report recommends that the support be provided.

[sector assessment requirements for support]

2. *Update sector assessments*

We didn't discuss this, but I am proposing that sector assessments be reviewed periodically to ensure they remain current and required. My concern is that this will be a fast moving space and the attractiveness of sectors may change.

The proposed amendment is inserted after Clause 6, page 8 (after line 19), at the end of clause, to say:

(6) If a sector assessment has previously been conducted for a sector and Future Made in Australia support has been provided in relation to the sector, the Minister must, by notifiable instrument, direct the Secretary to conduct a supplementary sector assessment for the sector at least once every 5 years.

[conducting supplementary sector assessments]

I would welcome any feedback/further discussion.

Thank you for your representation on 29 March 2023 on behalf of your constituent, concerning the Australian Prudential Regulation Authority's authorisation process for new authorised deposit-taking institutions (ADIs) and the process for their implementation.

APRA's approach to new locally-incorporated entrants in the banking industry is set out in an information paper released in August 2021, *ADIs: New entrants – a pathway to sustainability*.

I am advised that prior to the information paper being finalised, APRA undertook a robust consultation process, that included the release of a consultation paper in March 2021. Further, I understand that following the consultation period, APRA released a response paper that detailed APRA's responses to the feedback received during consultation. APRA also consulted with the then Office of Best Practice Regulation (OBPR), which works to ensure Government policy and decisions are supported by the best possible evidence and analysis.

As an independent statutory authority, there is no requirement that information papers are independently reviewed. However, as you would be aware, there is significant Parliamentary oversight of APRA and the approach it takes to fulfilling its mandate.

While it is important to ensure that new entrants can be granted a licence, it's critical that there is an appropriate balance between supporting entities to enter and thrive in the banking sector, while also ensuring financial system stability and protecting the interests of depositors.

Thank you for your representation on 21 December 2022 on behalf of your constituent **s 22** concerning the application of goods and services tax (GST) to exercise physiology. I apologise for the delay in responding to you.

I recognise the value that exercise physiology can provide to members of the community to support their wellbeing. It is important for the Government to consider whether there are appropriate mechanisms to support the many valuable services provided in society.

The GST applies broadly to goods and services with only a limited number of exemptions in areas such as health and education. Limiting the number of exemptions helps to minimise complexity in the GST system.

To meet the requirements to be GST-free under section 38-10 of the GST Act, exercise physiology would need to be performed by a recognised health professional and be recognised by that health profession as being necessary for the treatment of the recipient.

The revenue from the GST, though levied by the Commonwealth Government, is provided to the states and territories. This provides a secure source of funding to assist them in providing essential services, such as health and education. Under Commonwealth legislation and the Intergovernmental Agreement on Federal Financial Relations, changing the application of GST, such as to exercise physiology services, would require the unanimous support of the states and territories.

I appreciate the time you have taken to convey **s 22** concerns with the current system. The Government welcomes the views of the public in relation to matters of public policy and values the interest that the public takes in these issues.

Removal of GST on exercise physiology services

I recently met with a Curtin constituent, s 22 who is an accredited exercise physiologist s 22 s 22

s22 is requesting for exercise physiology services to become GST exempt. Accredited exercise physiologists are the only stand-alone health professionals providing chronic disease services that have not been granted GST exempt health service status. This issue has been ongoing since exercise physiologists were added to Medicare services in 2006.

s22 agreed to support a proposal for a revised principles-based approach to health services GST exemption, which would support the removal of GST on the exercise physiology services. s22 further advised that previous Parliamentary Budget Office analysis of this proposal determined it will have minimal impact on Commonwealth finances but would make these services more affordable for those patients with a disability, a chronic or complex health condition or an injury.

I gather that this proposal has been considered and supported by the Council of Federal Financial Relations.

Please advise if and when this change will be implemented.

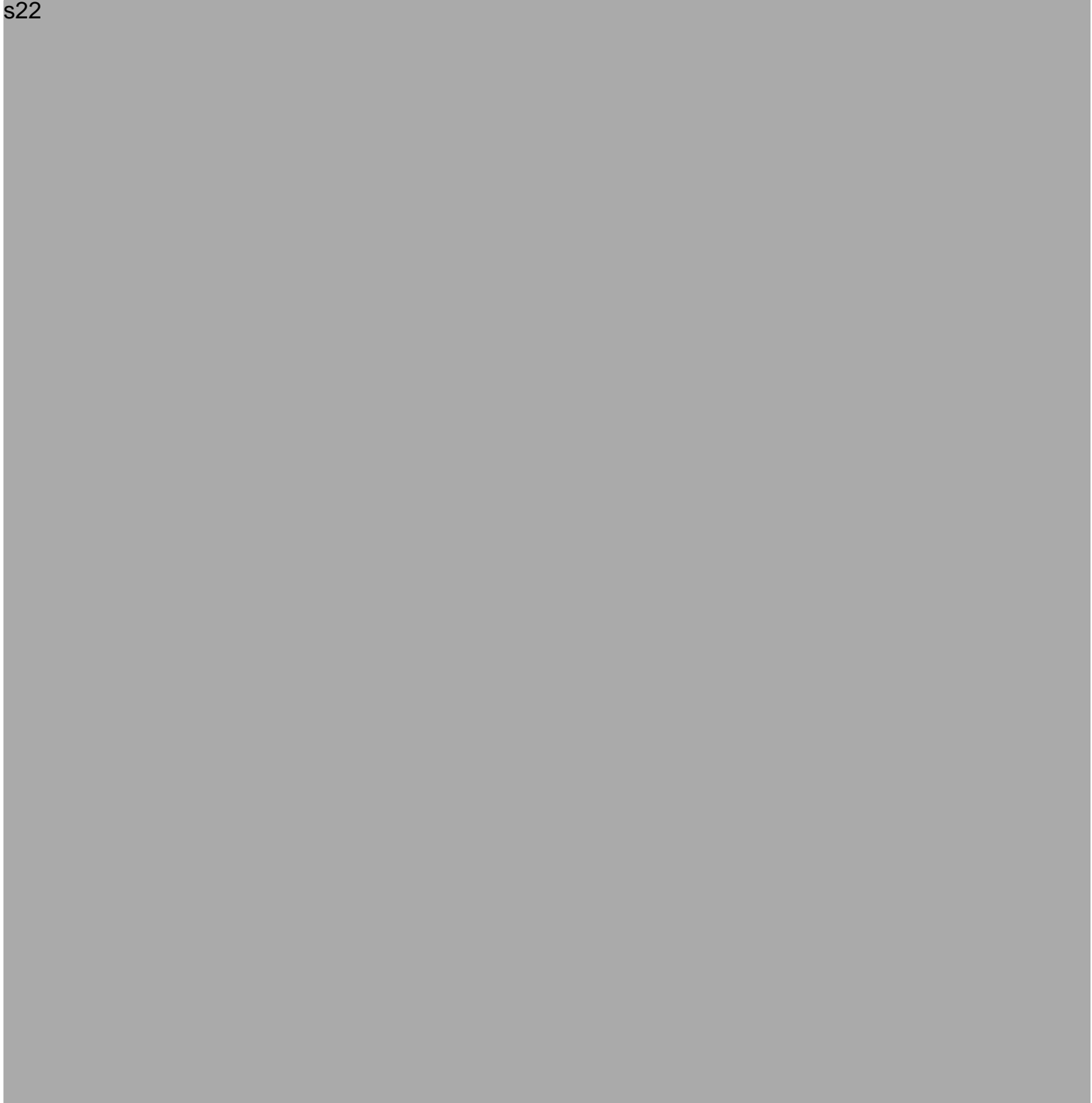
