ABOUT THE AUSTRALIAN TAXATION OFFICE

The Australian Taxation Office (ATO) is a non-corporate Government entity that sits within the Treasury portfolio. It is the Government's principal revenue collection agency, administering the legislation governing tax, superannuation and registry systems.

ABOUT THE ROLE

The ATO Commissioner leads one of Australia's largest Government agencies and employers.

The ATO Commissioner holds a range of powers under Australia's tax and superannuation laws and their primary function is to administer the taxation system in accordance with the laws that underpin it. The Commissioner is also the accountable authority under the *Public Governance*, *Performance and Accountability Act 2013*, responsible for directing and managing ATO's delivery on its purpose and obligations.
